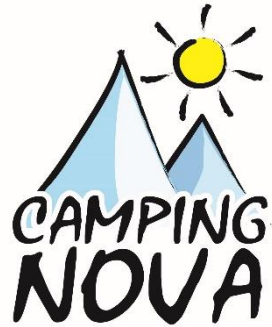


# Camping Nova Family Lorenzin



## *Dear campers, here are a few rules for the use of the campsite grounds.*

*Dear camping friends,*

We are pleased that you have chosen our campsite and wish you a relaxing stay. In order for your stay to be pleasant and relaxing, we ask you to observe the following rules:

### **1. ARRIVAL**

---

Access to the campsite is only allowed after registration at the reception. This also applies to short-term visitors. Young people travelling alone up to the age of 18 must present the written consent of their legal guardians when registering. By registering, the camper declares that he has familiarized himself with the site rules. The payment of camping fees is possible during opening hours from our reception. Daily from 7:30 to 11:00 and from 14:00 to 20:00. Booked / reserved days will be charged in full in case of early departure / hut tour!!!

Arrival should be done before 18:00 if this is not possible, please call us.

### **2. GUESTS**

---

Day visitors must report to the reception upon entering the campsite and pay the appropriate fee. The current price list applies.

### **3. VEHICLES**

---

Cars and motorcycles must be parked next to the tent or caravan in such a way that they do not obstruct traffic and neighbours. In principle, only one car is

allowed per parking space. For additional cars fee will be charged. In general, there is a speed limit of 10 km/h throughout the campsite area.

#### **4. NOISE**

---

Please be considerate of the other camping guests and avoid disturbing noise. In particular radios, televisions, music systems, as well as musical instruments, etc. are to be used in such a way that the neighbours are not disturbed.

#### **5. REST TIME**

---

From 22.00 to 6:00 o'clock is night rest. During this time, driving on the course is only allowed if no unnecessary noise is caused.

#### **6. SAFETY/SOURCES OF DANGER**

---

It is not allowed to dig ditches or fence your pitch on the campsite. Make sure that no one is endangered by tent pegs, tent cords or other camping accessories. Mark poorly identifiable sources of danger with clearly visible markings. In addition, a valid gas test must be presented.

#### **7. CLEANLINESS**

---

##### *Sanitation*

We kindly ask you to leave the washrooms as they wish to find you. From 11:00 to 14:00 we are busy cleaning and cannot do check in and check out. Therefore, the chemical toilet should also be avoided during this time. (The room is locked!!!) Pets & cigarettes (including cigars & pipes) have no place in the sanitary building. The sinks, toilets and wet rooms must be left in perfect condition. Please do not leave children under 6 years of age alone in the sanitary building.

**Non-campers are not tolerated in the sanitary building!!!!**

#### **8. WASTE DISPOSAL**

---

The waste must be separated and disposed of in the containers or containers provided for this purpose. If they are garbage bags, we ask you to dispose of them only knotted so that this does not lead to dirt and odor nuisances. If there is a desire to dispose of a caravan or other bulky waste, this is to be discussed with Alexander.

## **9. BARBECUES/CAMPFIRES**

---

Campfires or open fires are prohibited throughout the campsite. Barbecuing is only allowed on the designated pitches. Embers and fires must be constantly monitored. In case of increased forest fire risk, the groundskeeper can pronounce a barbecue ban. The barbecue area is cleaned immediately after grilling and left clean.

## **10. DAMAGE**

---

In the event of damage to facilities and facilities of the campsite, the person responsible for the damage is liable. We assume no liability for theft or damage to guests' property by third parties as well as injuries or accidents. We therefore recommend a private insurance.

## **11. CHILDREN**

---

Parents must always supervise their children responsibly. In case of violation of the duty of supervision, they are liable for damages caused by the children.

## **12. PETS**

---

All pets must be registered and may only be kept on a leash. The animal must not pose any danger or cause unacceptable disturbance. Contamination by animals is not allowed on the campsite. Should this nevertheless happen, these must be removed immediately by the pet owner.

## **13. DOMESTIC RIGHTS**

---

In exercising the domiciliary right, the management may also refuse regular guests with a fixed pitch without further reasons or, in the worst case, to expel them from the site and can also refuse to accept persons or expel them from the site if this appears to maintain security and order on the campsite.

For permanent campers still important, should more than 2 seasons rent be overdue, I (Alexander Lorenzin) take the right to have the caravan valued by an expert and, if necessary, to dispose of the caravan for a fee.

The costs incurred shall be borne by the tenant. There is the possibility to dispose of the caravan or motorhome by us. The price will be individually designed but can also be rejected by us due to the construction.

## **14. DEPARTURE**

---

Check-out must be done by 11:00 am. Otherwise, a further accommodation fee will be charged. Please leave your pitch in a clean condition. Booked / reserved days will be charged in full in case of early departure / hut tour!!!

## **15. PERMANENT CAMPERS/LONG-TERM CAMPERS**

---

For our permanent campers, the winter season 2023/24 will be about 1070, - (incl. ZWA) €. The summer 2023 makes 1000, - € (incl. ZWA).

The environmental fee for winter campers is € 80,- for campers who spend winter & summer with us € 100,-. If you pay the rent (summer) until 31.07. and (winter) until 31.12., you will not get a surcharge. Currently, the electricity price is 0.90 € per kWh (we hope that there will be no more increases).

**For the winter campers 2023/24 who arrive after 15.10. there will be installation dates, the reception will no longer be occupied from 15.10.**

***The surcharge for late payers is € 100.-!!!***

This year's winter season 2022/23 starts with the lift start and is expected to end on 16.04.2023. The campsite will be closed again from 16.04.2023 at 17:00 until 26.05.2023 at 08:00.

***From 16.04.2023 17:00 the whole campsite & sanitary building will be closed until 26.05.2023 8:00!!!***

The course fee includes 2 adults and 2 children (under 14 years), each additional car or person is chargeable.

Children up to 2 years are free. The 4 persons must be communicated at the time of registration, otherwise they will be charged separately.

***There are also no parents-in-law and children-in-law allowed in the package!!!!***

Safety:

Walking and driving on the paths is at your own risk. In case of rain, snowfall, and frost, please see for yourself whether the weather conditions allow this. The paths cannot be always cleared and in any case. At the intersection with the cycle path, the cycle path has priority. I hope it is taken into account so that there is no accident.

## *Additional*

**The trade in goods and goods is prohibited on the campsite**, should there be a desire to sell a caravan on the campsite, Alexander must be informed immediately (extensions and conversions may have to be removed), in this case a fee of 500,- € would be due.

For campers who want to give away the caravan for free or for a favor price the amount increases to 1000,- €. Handovers are not permitted during the current season, otherwise the new tenants must pay the daily rate (persons). Furthermore, we also take the right to refuse guests, including regular guests, with a fixed parking space without further reasons or, in the worst case, to expel the place.

**Construction, additions and conversions are to be discussed with Alexander, otherwise everything will be dismantled as it was!!!!!!!**

Construction activities are not permitted during the high season, from the beginning of July to mid-September. The camping guests are liable for all damages caused intentionally or negligently. We cannot accept any liability for any damage caused by theft, loss or other damage suffered by the course users.

Cars, motorhomes and caravans are pulled up free of charge in winter, but no liability is accepted for damage!!!

For permanent campers with dogs, a fee of 60,- € per winter season is to be paid.

Dogs must always be kept on a leash throughout the campsite. The dog excrement must be disposed of by the respective dog owner without exception. The dog toilets are outside the washroom the other at the Illweg valley. **I hope they will be used!!!!**

The drying room and ski room are cleared out by us after each winter season and locked in the barn. If skis or ski boots are not picked up after a winter season, everything will be disposed of.
